Key Accountabilities

- Provide legal services to the Corporation including the negotiation and documentation of corporate business transactions and initiatives to ensure compliance with legislation, regulations, case law, and corporate policies.
- Provide legal solutions that support integration of business decisions with the corporate strategic direction.
- Identify legal issues and provide guidance and advice to determine the optimum corporate position in legal and business matters.
- Research, gather and evaluate information to determine the business requirements and impact of applicable laws, contractual terms, corporate policies and industry practices.
- Conduct, in conjunction with business units, negotiations and achieve resolution of legal issues based on law, contractual terms, corporate policies and industry practices to mitigate liability and risk to the Corporation.
